



## 4<sup>th</sup> Annual Three Rivers Roleo Log Rolling Tournament Saturday August 13, 2011 Great River Landing in Onalaska, WI

Three Rivers Roleo is a partnership with the Onalaska Enhancement Foundation, and Onalaska Park and Recreation. This double elimination tournament will be held on carpeted logs for amateur, adult sport, and professional log rollers. All divisions with 4 people or less will roll a round robin. USLRA rules will be followed. Logs for amateurs 10 & under will be held for the start. 10 & up will be pole starts if skill allows. The smallest log will be a #4 log. **Note:** The event is at the waterfront. You may want to bring a blanket, lawn chairs, or a cooler.

You'll find the Great River Landing by simply following Main street west to the Black River and Lake Onalaska, right past Irvin Street (highway 157 and highway 35). Please park at the top of the hill near the bike trail and walk down the hill.
